# We Did It !

Members and friends of the First Hebrew Congregation have raised \$50,000, successfully meeting the Challenge Grant from the Horwitz Charitable Fund of Tem, Jonah, Mihal Rose and Daniel Joaquin Horwitz, where the Fund matches dollar-fordollar money raised by the Shul. The challenge was offered by the Horwitz Charitable Fund early 2012, with the condition that the \$100,000 be used for the total restoration of the 85 year-old synagogue building and that all funds be raised within two years. Raising the \$50,000 took only 18 months and gifts came from congregants and friends nationwide.

"The response of the First Hebrew Congregation has been outstanding." Says Tem Horwitz." "From the fund's perspective, it's been gratifying to see our Shul recruit new members and strengthen the involvement of the current members to build a strong future." Horwitz, a FHC member and long time resident of Covert and Chicago, describes himself as someone who "Teaches Tai Chi Ch'uan, has a diminutive publishing company and a tiny real estate empire in Chicago"

Adds Temple President Barry Fidelman, "This huge accomplishment shows that our small and historic community can swiftly and successfully come together to meet a challenge."

Once the first \$25,000 was raised and matched last fall, much needed work was done to the synagogue's masonry, fascia and soffits, and new copper gutters and downspouts were installed. The next restoration project may be an upgrade of our bathrooms. Heating and cooling problems are also being analyzed along with outside building drainage, to decide building restoration priorities. Fundraising may continue to deal with required building needs.

As word spread that we neared the fund raising goal, several congregants came forward to pledge and put us 'over the top' by several thousand dollars. They include Alvin Block, Arnold and Krystyan Kamen and the Esther and Seymour Padnos Community Fund. Additional gifts are still welcome.
